Subject: Licensing Committee Appointment 2024-018

1. **RECOMMENDATION:**

It is recommended that:

- By-law 2024-018 being a By-law to Appoint Members to the Licensing Committee be taken as having been read three times and finally passed and the Mayor and Clerk BE AUTHORIZED to sign same;
- **2.** That the 2022-2026 Committee Terms of Reference **BE AMENDED** to include the Licensing Committee as noted in the report of April 9th, 2024.

2. BACKGROUND:

On August 14, 2023 Council provided direction that "Administration BE DIRECTED to open a call for applications to appoint 5 lay members to the Licensing Committee for the 2022-2026 Council term."

On February 12th, 2024, Council voted to appoint 5 members of the community to the Licensing Committee through Council resolution.

3. DISCUSSION:

The Licensing Committee Terms of Reference document has been provided to coincide with the formal appointment of the committee in By-law, and to provide the parameters

for the committee specific terms of reference requirements. Section 9.1 of the Short Term Rental By-law 2023-059 provides for the Town's Licensing Committee purposes.
