
**Location of Property: 3465 Concession 3 N (Roll No. 3729-400-000-06900)**

**Purpose of Consent Application B/03/25: The applicant is proposing to sever a parcel of land being 33.5 m (110 ft) ± width by 24.4 m (80 ft) ± depth with an area of 817.5 sq m ± to merge with the abutting property at 3471 Concession 3 N.**

**The retained parcel being 102 m +/- of frontage by an irregular depth with an area of 8.256 ha is an existing undersized lot which contains a single detached dwelling, two accessory structures and approximately 6 ha of woodlot.**

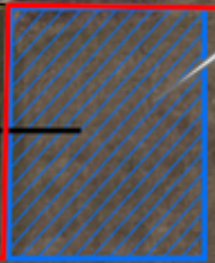
