Subject: 2nd Concession North Engineering Services – Request for Proposal Results

#### 1. <u>RECOMMENDATION:</u>

It is recommended that:

- The engineering services for the rehabilitation / reconstruction of 2<sup>nd</sup> Concession North from South Riverview Drive to County Road 10 BE AWARDED to Hrycay Consulting Engineers Inc.;
- An over-expenditure of \$13,005 BE APPROVED for a total not to exceed \$138,005.00 (including net HST) to be funded as outlined in the report from the Manager of Engineering dated May 24<sup>th</sup>, 2022; and,
- The Mayor and Clerk **BE AUTHORIZED** to execute an agreement with Hrycay Consulting Engineers Inc. for the Engineering Services for 2<sup>nd</sup> Concession North Rehabilitation / Reconstruction.

### 2. <u>BACKGROUND</u>:

The Town advertised a Request for Proposals (RFP) online to provide engineering services for the rehabilitation / reconstruction of 2<sup>nd</sup> Concession North from South Riverview Drive to County Road 10 on March 7<sup>th</sup>, 2022 via Bids and Tenders and on the Town's website.

The work requested includes all engineering services required to complete tasks related to the rehabilitation / reconstruction of the Second Concession as outlined in the RFP.

### 3. <u>DISCUSSION</u>:

Proposals closed for this project at 11:00 a.m. on March 24<sup>th</sup>, 2022. The Town received two (2) submissions that were processed electronically via the Bids and Tenders system.

The 2 proposals were reviewed by the evaluation committee. The evaluation committee consisted of the Manager of Engineering, the Engineering Technologist and the Manager of Roads and Fleet. Each individual ranked the proposals separately based on established criteria, then the committee met with the Purchasing Coordinator to determine a combined group score based on comparing the individual scores. Based on these scores the committee identified that Hrycay Consulting Engineers Inc. provided the best proposal.

The two proponents were ranked as shown below:

# 4. <u>RISK ANALYSIS:</u>

Not awarding this engineering would delay the replacement and improvements to infrastructure and could expose the Town to increased liability with respect to the condition of the road.

## 5. FINANCIAL MATTERS:

The 2022 Capital Budget includes \$125,000 for the engineering services related to the 2<sup>nd</sup> Concession North. Based on the recommended proposal award, the financial impact is estimated as follows:
