Subject: Acceptance and Assumption of Kingsbridge Sanitary Trunk Sewer

1. **RECOMMENDATION:**

It is recommended that:

1. The recommendations of the consulting engineer, Baird AE regarding the assumption of the Kingsbridge Sanitary Trunk Sewer on Maintenance **BE ACCEPTED**; and,
2. The Kingsbridge Sanitary Trunk Sewer **BE ACCEPTED AND ASSUMED**.

2. **BACKGROUND:**

The Kingsbridge sanitary trunk sewer travels from the corner of Knobb Hill Drive / MacLellan Avenue to the intersection of Cambridge Court / Whelan Avenue. The installation of this sewer brings sewage from the south end of Kingsbridge to the main pumping station on Kingsbridge Drive. This sewer allowed for the decommissioning of the pumping station on Knobb Hill Drive and the elimination the sewage from Kingsbridge flowing through the Texas Road sewer.

3. **DISCUSSION:**

In the winter / spring of 2020 the Kingsbridge Sanitary Trunk Sewer was installed.

The infrastructure was accepted and placed on a 1-year maintenance on June 22, 2020. The Town attended a walkthrough with the consulting engineer Baird AE, the developer and the contractor in October 2021, where the work was inspected. The contractor was also required to video camera the mainline sewer as well as the connections. A few minor deficiencies were noted that have now been resolved. Administration concurs with the recommendation of Baird AE to assume the sanitary trunk sewer

4. RISK ANALYSIS:

The Town assumes a financial risk by assuming these assets. The assets will now be included in the Asset Management Plan (AMP) where the financial implications of future lifecycle maintenance and replacement must be considered.

5. FINANCIAL MATTERS:

The Town has a self-renewing letter of credit of \$206,818 from the developer, which is equivalent to 25% of the value, and provided financial security for maintenance performed by the developer until the infrastructure is assumed. The letter of credit will be returned to the developer once the infrastructure is assumed, which is the recommendation of this report.

The developer's cost to place the infrastructure (sanitary sewer) in 2020 was \$732,100. Upon assumption of the asset, the Town will include it in its tangible capital asset (TCA) inventory, and add it to the AMP for future infrastructure replacement.




