3. DISCUSSION:

The goal of the Amherstburg Fire Department is to provide fire protection services through a range of programs designed to protect the lives and property of the inhabitants from the adverse effects of fire, sudden medical emergencies or exposure to dangerous conditions created by man or nature.

To achieve this goal, the Amherstburg Fire Department utilizes fire suppression and rescue activities, fire inspections, fire investigation, public fire safety education and

other fire protection programs as defined by the Fire Protection and Prevention Act, R.S.O.1997. and the Town of Amherstburg, Establishing and Regulating By-Law # 2022-035.

The attached, represents activities and program information for the 4th quarter of 2022. In addition to the attached activities, the service also participated on the St Clair College Advisory Committee for the Pre-Service Fire Fighting program.

The Department participated in "New Council" orientation sessions.

Emergency Managers participated on the Provincial Nuclear Emergency Management Coordinating Committee (NEMCC) Meetings.

2023 Budget preparation involved all members of the Fire Management Team throughout the quarter.

Final interviews were conducted for all successful candidates participating in the previously reported Officer Development (Captain) and preparation initiative.
